Marco GIACALONE

Research Professor at the Private and Economic Law department (PREC) and Co-Director of the Research Group on Digitalisation and Access to Justice (DIKE) at the Vrije Universiteit Brussel (VUB). He has been leading and/or involved in several collaborative research projects (co-)funded by the European Union. His work analyses the transformations of law in the field of Access to Justice with a special focus on the fields of Private International Law, Alternative Dispute Resolution (ADR) and Online Dispute Resolution (ODR). He earned a Ph.D. in law (Doctor Europaeus, 2016) from VUB and Naples' University Federico II with a thesis on Dispute Resolution and New IT Realities.



Elisabeth ALOFS

Principal Adviser on the Digital Transition in the Directorate-General for Justice and Consumers of the European Commission. Before, he was the Director responsible for Fundamental rights and Union citizenship, the lead Director for the reform of the EU data protection legislation, the "Snowden" follow up, the negotiations of the EU - US Privacy Shield and the EU Code of Conduct against Hatespeech on the internet. Before joining DG Justice, he held posts in the Legal Service of the Commission, the Cabinet of Commissioner Nielson, and in the Directorates General for Trade, Transport and Maritime Affairs. He has a broad experience as agent of the Commission in litigation before the European Courts and he has published extensively on EU law.

Tatjana JOSIPOVIĆ

Professor of civil law of Faculty of Law, she acted as a member of the working groups that drafted the Inheritance Act, Property Act, Land Registry Act, Agricultural Land, Enforcement Act. She has written many papers and several books on civil law and European private law and presented papers in numerous national and international conferences. Prof. Tatjana Josipović was a head of the task-force preparing Croatia's accession negotiations in the chapter Right of Establishment and Freedom to Provide Services; member of the task-force preparing accession negotiations in the chapter Free Movement of Capital. She was awarded a research grant at the Max Planck Institut für ausländisches und internationales Privatrecht, Hamburg on several occasions. She is a recipient of the State Award for Science in the area of social sciences (2019).



Paola GIACALONE

Paola is a PhD researcher at the PREC department and a member to the DIKE research group. As part of her research, she is mainly focused on evaluating the use and efficacy of private international law, as well as online (alternative) dispute resolution models to promote access to justice. She has been involved in several ongoing EU projects including EFFORTS (Towards more EFfective enFORcemenT of claimS in civil and commercial matters within the EU EFFORTS) and SCAN II (Small Claims Analysis Net II). She post graduated at the school of Legal Profession at the University Guglielmo Marconi of Rome (2015) and got a LL.B from University of Naples Federico II (2013). Her LL.B dissertation concentrated on the system of European sources of civil procedural law. Paola is also a member of the Italian Bar.



Flora AMATO

Associate Professor Tenure Track at the Department of Electrical Engineering and Information Technology of University of Naples Federico II where she works since 2006 and Professor of Artificial Intelligence for the Master degrees in Computer Science and Electronic Engineering, Automation and Telecommunications, at Engineering Courses of the University of Napoli Federico II. She gained qualification for Associate Professor in August 2017. She graduated summa cum laude in Computer Science at the Faculty of Mathematics, Physics and Natural Sciences at the University Federico II of Naples in 2005. In 2009 she obtained a PhD in Computer and Control Engineering at the same University. She was visiting researcher at the Department de Ciències de la Computació of the Universitat Politècnica de Catalunya, Barcelona (Spain) in the period from March to April 2013, where she collaborated with Prof Fatos Xhafa on semantic techniques for the definition and the composition of processes. She was a visiting researcher at the Department of Computer Science of the University of Maryland (USA) in the period from February to March and September 2015.



Daša TIČAR

Nishat HYDER-RAHMAN

Nishat's research focuses on the intersections of law, ethics and technology in society. Her expertise is in the domains of medical law and bioethics, and family law. She is particularly interested in policy and regulatory approaches to current and future technologies, from government-led to self-regulatory measures, at both a national and international level. Her research focuses on families, from formation to dissolution. Her current independent research explores the legal and ethical aspects of the creation and regulation of family relations in the context of assisted reproductive technologies. At the same time, as post-doctoral researcher on the CREA2 project, she is exploring how technology - namely, Al and algorithms - can assist in dissolving family relations, and how these novel solutions will impact and interact with the pre-existing regulatory landscape.



Naivi CHIKOC BARREDA

Naivi Chikoc Barreda is Associate Professor at the University of Ottawa (Civil Law Section) and member of the Quebec Chamber of Notaries. Her research interests cover a wide range of topics in the field of Private International Law (PIL): contracts, torts, family, property and succession law. She is currently conducting research projects on digital transformation and PIL, with a particular focus on the international circulation of notarial instruments drawn up remotely, cross-border marriages and out-of-court divorces.


